REQUEST AND AFFIDAVIT

I hereby waive my right to a jury trial, and enter a plea of **NO CONTEST**//**GUILTY (CIRCLE A PLEA)** and elect under Art. 45.0511, CCP, to take a driving safety course. I state under oath that on the date of my request for a driving safety course/motorcycle operator training course in the above numbered cause that I was not taking such a course nor had I completed one within the 12 months preceding the date of my current offense.

I understand that on the date of my request I must present to the court the following:

1. a valid Texas driver's license or permit; or proof that I am a member, or the spouse or dependent child of a member, of the United States military forces serving on active duty
2. proof of financial responsibility pursuant to Chapter 601, Transportation Code (automobile liability insurance);
3. payment in the amount of \$114.10 (**\$139.10 if the violation occurred in a school zone**; this amount includes court costs and all administrative fees (personal checks are not accepted).
4. I understand that I do not qualify to request the driver's safety course for dismissal of a citation if:
  - I hold a commercial driver's license or held a commercial driver's license on the date of offense;
  - Committed an offense in a construction zone;
  - Speed over 25 miles over the posted speed;
  - Speeding 95 mph;
  - Passing a school bus;
  - Failed to stop and give information;
  - Failed to Yield Right of Way violation that involved an accident with bodily injury.
