CR-05 - Goals and Outcomes

**Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)**

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

Most all Activities and Projects for the 2021 program year (Oct 1, 2021 – Sep 30, 2022) provided fewer results than initially anticipated for the report period. Public Service programs proposed assistance to 3,800 persons with an additional 120 persons assisted with prevention of homelessness; Housing- Rehab Existing Owners estimated 12 units and Housing – Tenant Based Rental Assistance (TBRA) estimated 35 households benefitting. Public Facilities, Infrastructure/Improvements (City owned) estimated 3,500 benefitting and PFI Nonprofit Owned 230 children and families anticipated. Other Community Needs/Improvements – Code Enforcement estimated 500 addresses would be addressed through local code violations, and then for Planning and Administration 1 each estimated for CDBG and HOME programs for the 2021 year. **The results of these estimates are as follows:** Public Service programs assisted 3,066 (81% of anticipated) persons, with an additional 531 (443% of anticipated) persons assisted with prevention of homelessness; Housing – Rehab Existing Owners assisted 2 (17% of anticipated) households / units and zero households assisted through TBRA. Public Facilities, Infrastructure/Improvements (City owned) and (Nonprofit owned) both had zero results – PFI – City owned was an “add” to other CDBG and City funding for the Gilmore Center construction project which was delayed due to reduced City staff in the engineering department; the PFI - Nonprofit owned was for Central Texas 4C, Inc. to add raised garden beds to 4 Head Start Centers. The organization decided to return the allocation of funding and focus on completing the newest Head Start Center in Killeen on Avenue C -also funded by 2019 CDBG and Head Start funds. Code Enforcement worked in the North Killeen Large Target area with concentration on the older neighborhoods on the northern most sector of that area with a total of 9,885 in the service area having 75% (approx. 7,414 low-income persons) of the area considered as low-income. The Code Officer addressed 394 violations on 214 different properties in the designated area. The annually funded Code Enforcement Officer position is not a desirable position as the looming doubt of continued funding is always at the recommendation from the Advisory Committee to Killeen City Council. Each employee that has been in this position has immediately transferred to a position funded by the Killeen general fund providing stability instead of the uncertainty of an annual funding request from CDBG. Finally, the Planning and Administration did result in one (1) each accomplishment for CDBG and HOME programs.

The jurisdiction completed two owner occupied housing rehabilitation activities during the report period for Program Year 2021 – both activities assisted low-income households with demographics of 1 White, 1 Black/African American; all are non-Hispanic. The jurisdiction started a third unit for rehab however it was late in the report period and the activity did not complete until after the report period was over – all info will be subsequently reported in the next report period.

The City of Killeen estimates approximately \$99,268.00 was leveraged through federal, state, and local resources for programs that were

delivered through local health and human services programs.

**Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.**

The jurisdiction continues trying to stay on track in accomplishing proposed goals for public service programs and owner-occupied housing rehabilitation. Public Service programs assisted slightly less than expected which due to the impacts of the Coronavirus on the community and the continued rising cost of living expenses, to include both housing and food, has left agencies with less funding to help while costs continue to increase. Public Services in general are a high priority in the strategic plan and these funds are limited by federal statutory requirements. If agencies do not use all their allocated funding, remaining funds not used under the Public Services category will then be used for other eligible CDBG activities in the next program year.

Housing rehabilitation activities are down from the previous report year. Continued marketing of the program draws interested owners to the program; however, most owners exceed the maximum income limits for participation and others do not meet the minimum 5-year occupancy requirement of the program. The program is marketed to the elderly populations, and they are very wary about providing personal information on their finances or insurance status. As elderly persons are usually on a fixed income There is also the worry that property improvements will increase the tax value and therefore their monthly expenditures. even if the program will assist Special target area (revitalization area) housing rehabilitation in the Conder Neighborhood was of no interest to those living in the area.

The jurisdiction's HOME program Homebuyer Assistance Program remained on hold due to the continued increases in sales prices on existing homes. Additionally, buyers still lack the ability to have the minimum \$1,000 participation requirement used as part of their down payment. Mortgage lenders have reduced the number of higher risk buyers with higher debt-to-income ratios as the market cooled in the last

12-15 weeks of the fiscal year. The homebuyer education class is in the category of group Housing Counseling.

**Killeen Texas CAPER2021**

The jurisdiction was still working projects from the 2020 program year at the end of the previous report period. Activities and Projects from that program year (Oct 1, 2020 – Sep 30, 2021) were completed during this 2021 reporting period with the following results: Public Service programs assisted 1,701 with an additional 347 assisted in the prevention of homelessness; Housing – Rehab Existing Owners had zero results after much time and effort was spent on promoting the 225.01-01 North Killeen reinvestment Program Housing Rehab which was part of a larger project that was funded just eight months after the onset of COVID-19. Due to lack of interest, the program will be cancelled with funds likely to be reprogrammed and used for other CDBG eligible (nonpublic services) activities. Other Public Facilities/improvements-City owned also suffered significant delays from COVID-19 to include PFI 225.01-01 Conder Park Improvements and the Street Reconstruction project proposed for the Conder Park neighborhood. The street reconstruction funds for this project were reprogrammed to be used for other CDBG eligible (nonpublic services) activities in the 2022 program year (Oct 2022-Sep 2023) however the funds for Conder Park Improvements as well as AA Lane Park Improvements were bid late (August 2022) in the report period and will be completed during the next report cycle. Code Enforcement Dangerous Building Abatement Program (IDIS #1144) from the PY 2020 year was also cancelled; apparently property owners stepped up after the final notices were mailed indicating the City would take action to demolish the substandard, unsafe units in the next 30-days. All prior known substandard structures were corrected and are now up to the local code, and the violations previously cited by the CDBG funded Code Enforcement Officer (IDIS # 1145) were paid. These properties and the target area of the Code Officer were in the North Killeen Large Target area with concentration on the older neighborhoods on the northern most sector of that area with a total population of 13,240 with 12,850 in the service area with 74.44% (approx. 17,262 low income persons) of the area considered as low-income. The Code Officer addressed 815 unduplicated properties in the designated area. Again, the annually funded Code Enforcement Officer position was not a desirable position as future funding by CDBG is always at the recommendation of the Advisory Committee to Killeen City Council. The Code Officer also transferred to a position that is paid by the Killeen general fund providing stability instead of uncertainty. Also, in the PY 2020, the Planning and Administration resulted in one (1) each accomplishment for CDBG and HOME programs.

The jurisdiction completed Activity #1132 – Subsistence Payments in Response to COVID-19, which utilized both CDBG and CDBG-CV funding from Program Year 2019. The activity provided various public services to the Killeen community to include payment of utility and rent expenses for Killeen residents directly affected by COVID-19 by loss of income, loss of hours at work, loss of employment, employment closure from the effects of the Coronavirus, or required people to quarantine due to contact with another person infected by COVID-19. The jurisdiction assisted 2,094 persons with emergency subsidy. The CDBG-CV funded activity for administration of the City of Killeen Subsistence Payments in response to COVID-19 was completed this report period. The final activity associated with the jurisdiction's CDBG-CV funding is IDIS # 1136- City of Killeen Public Safety Response to COVID-19 where funding was utilized for payment of pre-award and ongoing costs to facilitate urgent actions required of the jurisdiction to protect the community and its citizens with public health and safety measures necessary in response to impact of the Coronavirus on the Killeen community. To date, the activity has provided assistance to 20,959 Killeen residents; demographics for this activity will follow in the next report period. Additionally, the jurisdiction completed the PY 2019 activity #1162- Clements Boys & Girls Club North Killeen Gymnasium/Teen Center. This activity also suffered delay from Coronavirus and ability for the agency to obtain complete plans for the project. When the project was finally bid, the cost was in excess of the available funding from CDBG causing the agency to cover the additional cost which resulted in action by the nonprofit board; the action was approved to cover the difference in cost and the project was able to move forward and be completed in program year 2021. The agency provided beneficiary data for the one year following completion with the following results: 317 children have benefited from the actions taken at the Clements Boys and Girls Clubs downtown location with parents having easy access to drop off and pick up children through the reconstructed parking lot and sidewalk and designated (marked) walking areas at the center. CDBG funds were only used for parking lot and sidewalk reconstruction as a large anonymous donation paid to cover the entire construction of the teen center/gymnasium leaving CDBG funding for a small portion not initially included in the project but still vital to access the structure. Demographics for attendees are as follows: White 22% (63), Black/African-American 57% (182), Other multi-racial 18% (56) with 21% (65) of those considered Hispanic; there is less than 1% combined Asian, American Indian/Alaska Native, and Native Hawaiian/Other Pacific Islander (10). Of the total assisted 65% (164) are considered as low-income. The jurisdiction will have one additional activity under Public Facilities/improvements – Nonprofit Owned that was part of the 2019 program year completed during this report period that will provide beneficiary data for the next report period.

### Narrative

Table 2 - above indicates the racial and ethnic status of families assisted with CDBG and HOME programs funding during the 2021 program year. CDBG activities assisted a greater number of Black or African American (39% White; 55% Black/African American) household over other household types; this trend is consistent with the household demographics in the Killeen community needing assistance. Additionally, three other racial categories of households were assisted through CDBG funding, those were - Asian, American Indian or American Native and Native Hawaiian or Other Pacific Islander –with these combined households totaling 6% (.038% -110, 0.005% -15, and .021% - 61 of the 2,889 total) of all households. Participation by Hispanic households assisted with CDBG programs was higher than in previous years coming in at 12.5% (322 of 2,567) of the total households assisted; an increase of 6.5% from the previous year. The HOME program provided housing information and opportunities to a variety of racial groups as well with – Black African/American at 39%; White at 60% and 56% of the total assisted indicated their ethnicity as Hispanic.

Both CDBG and HOME programs continue to assist low-income households with each of the funded activities and encourages translation of materials, applications and information and adding bilingual staff to assist interested persons to connect with public service programs and housing activities subsidized by Killeen’s HUD-CPD funding. Generally, “advertising travels best by word of mouth” which is from individuals being assisted through a particular program or service then sharing that information among their peer group, this in turn gradually increases the number of persons assisted in each of the different racial and ethnic groups.

### Narrative

For the third year in a row, total funds expended included both the CDBG and HOME funds as well as the CDBG-CV funds as referenced in Table 3 above. The jurisdiction shifted its primary focus on expenditure of its entitlement CDBG funding instead of the CDBG-CV funding as impacts of COVID-19 are slowly ending regarding emergency subsistence to address the economic impact on individuals and families. However, the City's emergency responders continue to address COVID-19 related symptoms when making emergency calls therefore cardiac and AED items were purchased to help first responders to continue to respond to impacts of the coronavirus. The jurisdiction also engaged professional services for a homeless and mental health study and strategy in conjunction with the City of Temple, TX to better administer funding available to address homelessness and mental health and the effects of COVID on these special populations. At the end of this report period, the jurisdiction has dispersed 94.4% (\$1,265,851.61) of its \$1,340,517 of CDBG – CV funding on actions that prevent, prepare, and respond to the coronavirus impacts on the Killeen community.

Programs established in a 2019 Program Amendment (CDBG-CV funding) had to meet urgent needs of the Killeen community along with providing Killeen's first responders protections against the spread of COVID when addressing public safety. Residents also received 'subsistence payments' in the form of rent and utility assistance for households financially impacted by COVID-19 with loss of income, employment or who contracted the virus and had to quarantine, day camp for children of essential workers, and frozen meals and hot meals delivery for seniors on the meals on wheels program.

During the 2021 program year, CD staff continued to be inundated with housing assistance and utility subsidy requests from individuals and families still wanting/ needing assistance. Providing this assistance, developing the HOME-ARP Plan as well as keeping pace with day-to-day operations has caused additional delays of scheduled projects. The next reporting period will show significant progress as the community continues to adjust to the new normal and requires less assistance from staff.

**Narrative**

Local Target Areas received project funding for program year 2021-2022 however the distribution was not as initially planned for the geographic areas. Distribution for the defined areas is as follows:

**Local Target Area Small (LTASM)** – there were no proposed projects for the specific target area and no funds were allocated to a project in the area.

**North Killeen Revitalization Area** -as established by City Ordinance -proposed activities utilized 3% of the combined HUD funding. Overall, this target area received approximately \$52,325 of the combined HUD funding for Code Enforcement Operations and Salary (for designated target area).

**Local Target Area Large (LTALG)** - the jurisdiction estimated utilizing 46% of the combined HUD funding. This target area received \$755,803 of the combined HUD funding for Owner and Rental Housing Rehabilitation (HOME) and for the construction of the Killeen Bob Gilmore Senior Center wing

**Grantee Boundaries** - proposed activities utilized 51% of the HUD funding which included public service programs serving persons from within the grantee boundaries, HOME funded tenant based rental assistance targeting chronic homeless and households at risk of homelessness, set aside funds for community housing development organizations (CHDOs), and administration costs associated with CDBG and HOME program. This target area received approximately \$1,101,567 of the combined HUD funding.

Each of the local target areas above have higher concentrations of low-income households equal to or greater than 51% of the total population, has existing aged infrastructure, deteriorating residential dwelling units or units in need of rehabilitation to decrease a non-standard housing status. The local target areas also contain areas housing stock and infrastructure that pre-dates 1950.

The 2021 program year fund allocations resulted in amounts/percentages less than anticipated for those projects having the highest priority. Although most of the identified local target areas received allocations of the combined CDBG and HOME funds, the distribution came up short by as much as 50% and as little as 3%.

## Leveraging

**Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.**

Each separate agency leveraged funds through their respective entity with some combining the receipt of their CDBG funding award with other private, state, and local funding sources with the intention of delivering public service programs to more persons in the jurisdiction.

Based upon the information provided by HUD, the jurisdiction has once again received a zero percent (0%) match requirement for the program year 2021. The total match liability incurred from program year 2021 HOME expenditures is equal to \$0.00. The jurisdiction did not have expenditures of HOME funds requiring Match Liability, and no funds were used from the jurisdiction's excess match to meet requirements for its Match Liability. The jurisdiction will begin the next fiscal report period, PY2022 (Oct 2022 - Sep 2023), with the same balance as previously reported at the end of program year 2021 \$1,012,920.21 available and carried forward to be counted toward its coming match contributions for expenditure of its HOME program entitlement funds.

**Discuss the difference between goals and outcomes and problems encountered in meeting these goals.**

Annual goals proposed for program year 2021 again were ambitious and hopeful the economy would be on the upturn with program administration and activities back to pre-COVID 'normal'... this was not the case. At the onset of the program year, HUD notified the jurisdiction of additional funding from Treasury, as approved under the American Rescue Plan Act that had a primary focus of reducing the increased homelessness with heavy influence from other HUD programs that provide long term case management, counseling, and support services including housing assistance and counseling to families

and individuals who are at-risk of becoming homeless in the near future; the funding was identified as HOME-ARP funding and an allocation from HUD, based on the jurisdiction's standard annual HOME grant formula, in the amount of \$1,778,641. CD staff focused on the HUD provided training and information webinars on the new allocation of HOME-ARP funding. HOME funded rental assistance was put on the back burner for two reasons, no local agencies available to provide long-term support services for persons suffering from chronic homelessness and focus shifted to conducting consultations [required of HOME-ARP] with area providers to determine capacity and need to fill the housing and services gap that are prevalent in the community.

The 2019 HOME funded Families in Crisis activity that was to provide tenant based rental assistance to victims of domestic violence also stalled so the agency could focus on the use of their special purpose funding from the State of Texas to address impacts of coronavirus. The tenants benefitting from this program were previously reported in the 2019 CAPER and the activity was closed during this report period due to funding being reprogrammed for the 2022 program year; the agency returned the remaining funds because of low - no participation by local property managers and landlords.

Non-Homeless and Housing Rehabilitation suffered lack of participation due to owner's lack of providing required legal documents and because owners wanted to participate in having the unit rehabbed only to have it ready to lease out. It is clear the local public is resistant of federal funding at all levels even if the household would benefit in safer, more affordable housing situation. The jurisdiction estimated the above one-year goals for its PY2021 program year associated with the priorities identified in both the Community Engagement and Community Planning Meetings as well as the type of affordable housing that needs being addressed and identified in the Unity Within the Community 2020 survey which helped to establish the jurisdiction's housing strategy goals in the 5-year Consolidated Strategic Plan.

### **Discuss how these outcomes will impact future annual action plans.**

With continued 'special' funding being added by the Federal Government to assist persons impacted by the known 'COVID shut down', expenditures of annual HUD funding, from the formula grants program, are likely to be less than pre-COVID years. The Killeen community is now on a tract to attempt to arrest ongoing issue of homelessness and at-risk of homelessness, not only due to the long-term impacts from COVID-19, but now the unemployed workforce, low paid employment positions, increased cost of housing, food, utilities, transportation, and childcare that are burdening low-income households and individuals. Housing, Disaster Counseling, Transportation, and Employment are all now a priority over some other long-time funded services; creation and stand up of new service programs take time to establish and reach the families in the greatest need. A future of more effective ways to work with clients/beneficiaries in need will require new methods to have an impact on the community.

Although these statements regarding anticipated future impact and outcomes on Killeen's Annual Action Plan, they are just that, 'anticipated' and unpredictable for CDBG or HOME participation needs; the HUD programs are strictly voluntary. Voluntary participation does not always have the results or outcomes as programs that are pre-assessed in advance finding the exact number of participants eligible and willing

to utilize the federal programs. Low results this report year are not likely able to be made up in coming plan years, this in turn is likely to cause Consolidated Plan goals to be under the initial estimate.

**Narrative Information**

All CDBG and HOME funded housing programs require eligibility determinations based on income and household size, relative to HUD determined area median income (AMI) for the Killeen-Temple, TX metropolitan statistical area (MSA). Housing programs funded by both CDBG and HOME require income eligibility by household size therefore the above information is specifically associated with housing programs only. The CDBG funded housing rehabilitation program targets lower income and elderly households who own and occupy their home and those that are most likely to need rehab. Occasionally, the jurisdiction will receive applications from households that have more moderate income (over 50% AMI - between 60%-80% of the AMI) households. The number of extremely low-income households assisted is generally older in age and less accepting of "government assistance", whereas households of a younger generation readily accept programs made available by the federal government. These are usually households with current employment or have more than Social Security as retirement income. Two (2) low-income elderly households were assisted under the CDBG funded housing rehabilitation program - 1 low income (income equal to or less than 50% of the AMI) and 1 moderate income (income less than 80% of the AMI). Racial/ Ethnic and Income Level data for CDBG funded housing assistance is as follows: Race/Ethnicity = 50% (1) Black/ African American and 50% (1) White.

Shelter for Homeless Persons does not count toward the jurisdiction's outcome associated with housing as HUD counts those results under its own category as "number of homeless persons given overnight shelter."

HOME funded TBRA housing targets low-income (50% AMI and below) households due to the qualifying requirements for receipt of a Housing Choice Voucher (HCV). No households were assisted with HOME program funds during this report period.

**Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:**

### **Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs**

The actions taken are those conducted by local human service agencies and recipients of the jurisdiction's HUD funding. Homelessness and persons/families at-risk of becoming homeless remain a high priority within the community as it seems the number of persons in this category have not declined over the previous report year. The jurisdiction's HUD funds provide for programs that are directed to identification of homeless persons and an assessment of their overall individual health and welfare needs. This assessment would be easily conducted by using the HUD Coordinated Entry system whereby local human service agencies, especially those receiving HUD funding for homeless services and programs, work closely to refer individuals for services among each other and then assist in re-establishing the individual/household within the community. The jurisdiction's Community Development Department, located in downtown Killeen and near Friends in Crisis (homeless over-night) shelter, and Families In Crisis (domestic violence shelter) continue to house the Killeen Police Department's Homeless Outreach Team (KPD - HOT) - a dedicated police officer works directly with local businesses in addressing loitering of homeless persons, then individually with homeless persons by directing them to service agencies within the community. The HOT team also works with social work interns from the Texas A&M University Central Texas who assist homeless persons in communicating with local homeless providers to obtain services for the individuals that are referred to the HOT team. For this report period, housing of homeless persons or persons who are unsheltered has been the greatest need. Local apartment complexes must maintain a 'community cohesion' among tenants and are not as willing to accept 'homeless persons' even with a full payment voucher for several months or more. Property managers /landlords not required to accept a payment voucher for a tenant and have the mind set of protecting their 'owner's property' instead of leasing to a tenant without a leasing history or ability to pay for their own rent and utilities or food, clothing, and furniture. The City, local homeless service providers, and the Central Texas Council of Governments' Housing Division worked together to help identify individuals and families in need of stable housing to utilize any remaining Emergency Housing Vouchers issued to HCV Administrators to keep or rehouse persons who were homeless. Voucher acceptance is still a concern because the local providers who are familiar with the vouchers are quickly changing their minds and are not as willing to accept a voucher for partial payment. Additionally, finding a qualifying unit in a location the household wants to be in and at the voucher issued rent amount continues to be difficult in the community. The jurisdiction will continue to support agencies in their collaboration in applying for other program funding through the State funded Emergency Solutions Grant (ESG) or other HUD funding through the Continuum of Care (COC) Balance of State (BOS) and the Texas Homeless Network (THN) provided the funding request addresses a high priority population consistent with the jurisdiction's 5-year consolidated strategy.

## **Addressing the emergency shelter and transitional housing needs of homeless persons**

At present there continues to be no known 'transitional housing' programs in Killeen or funded by any other State or Federal program funding. Over the years, HUD has taken a different perspective on housing homeless persons in transitional housing with the 'housing first' model. Central Texas Youth Services operates an independent living program for youth transitioning from foster care to independence as adults. The agency owns 6 apartment type units on one property previously funded with McKinney-Vento and Killeen HOME funds. Families in Crisis, Inc. owns and operates the only overnight homeless shelter in the Killeen community - known as Friends in Crisis. The shelter, partially funded by CDBG facility improvement FY 2014 funding, serves all homeless persons in the community including those coming to the community specifically for the overnight shelter at this facility. The facility contains 78 beds for both men and women who are homeless and 4 rooms for homeless families. The shelter operates primarily from other federal and state grant funds received by the parent agency. The agency continues to attempt delivery of social service referrals to the persons seeking assistance as well as housing referrals and limited housing assistance. The agency also receives funding from other federal and State agencies to provide access to shelter and programs for veterans. Friends in Crisis provided some case management to 531 homeless persons through a position funded in part by the Killeen CDBG public services funds. This number continues to be more than double the annual HUD Point in Time counts of homeless unsheltered and sheltered persons counted in the Killeen community for the Bell and Coryell County areas.

Federal changes to programs assisting persons experiencing homelessness no longer require participation to receive assistance/continue assistance. Agencies serving this population see an increase in repeat requests for assistance with the change in the federal rules. Over this past year the jurisdiction lost one of the true homeless case management agencies - Heritage House of Central Texas (HHCT). The agency has struggled throughout its history in the community to gain financial support and recognition for its work with the homeless community. Since its inception, many thought the agency was duplicating the same services as Families in Crisis/Friends in Crisis (FIC) when most often, the staff from FIC referred homeless individuals to HHCT when the individual felt FIC was not providing services to assist them in the transition out of homelessness. In January 2022 the Executive Director and case manager parted ways with the agency and as the governing body had no desire to re-establish a new director or case manager, HHCT no longer operates in Killeen or the immediate area.

The Central Texas Homeless Coalition works with local human service agencies to work together and collaborate their efforts in reducing homelessness in Killeen, Temple, and Bell County Texas.

**Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that**

## **address housing, health, social services, employment, education, or youth needs**

Individuals and families are referred to various organizations and agencies who provide varying degrees of assistance through human service programs associated with domestic violence, adult and child abuse/neglect, housing, health and nutrition, utilities, and mental and physical health. These agencies tend to work together by directing persons (clients) to appropriate entities who can provide services for a particular need and because they don't often have enough funding to assist with all requests. At that time the entity networks and refers clients to other agencies for the needed services. It is unclear to the jurisdiction whether the referring agencies follow up with the receiving agencies to confirm if the individual/family was provided the needed assistance. The Bell County Commissioners Court continues to provide indigent and mental health services (Bell County Indigent Defense Mental Health Program (BCIDP) where repeat offenders/individuals suffering with mental illness or are in need of specialized care are assisted through a variety of network connections to human service agencies and are monitored by social workers and bachelor and Master level interns from participating schools including Texas A&M Central Texas, Baylor University, University of Mary Hardin Baylor and University of Texas. Court appointed defense attorneys continue to represent mentally ill offenders in the Bell County Criminal Justice System. These individuals are often extremely low-income, and others have supplemental income, which is lost to binge drinking, theft/mugging, or other uncontrolled/unexpected actions by the individual. The BCIDP works closely with area entities to ensure high risk/at-risk of homelessness individuals and families receive necessary assistance to address housing, health, social service, employment, and educational needs. It is unclear to the jurisdiction whether individuals referred to these services eventually achieve independence after release and referral; unsuccessful persons eventually end up being incarcerated again.

**Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again**

The jurisdiction continues to award CDBG funding to local agencies providing services and referrals with other entities to reduce the length of time persons experience homelessness. Bring Everyone in the Zone (BEITZ) continues to provide peer-to-peer counseling to veterans and their families, assists veterans -of all discharge types - with connecting to benefits, housing, health care, and income. During the 2021 program year BEITZ continued to help with two (2) counselor/case managers to assist in directing services to homeless veterans and veterans experiencing reoccurring homeless episodes.

Central Texas Youth Services continues to work closely with the State of Texas in housing children and adolescents removed from abusive homes, runaway youth and young adults transitioning from foster care to independence through its Option House and Project F.U.T.U.R.E. programs.

Killeen Independent School district works closely with area agencies in providing services, counseling, and assistance to homeless youth. Central Texas Support Services (CTSS) provides HIV/AIDS support services for the Bell, Coryell, Hamilton, Lampasas, Milam, Mills, and San Saba Counties in central Texas.

The Friends in Crisis over-night homeless shelter, owned and operated by Families in Crisis, Inc. (domestic violence) continued to see persons suffering from chronic homelessness despite the agency's efforts. Many persons experiencing homelessness often choose not to stay in the shelter, and many are prohibited from returning to the shelter due to not following shelter rules. Many homeless persons utilizing resources of the Friends in Crisis homeless shelter have stable monthly income that when combined with long term support services, rental housing subsidy, and appropriate support services, could result in reduction of 'convenience' or repeat shelter use allowing the agency to better target its resources for longer term results. Although the agency utilizes both the Continuum of Care (Balance of State) grant, Emergency Solutions Grant funds for specifically addressing rapid re-housing rental assistance program, however, there still seems to be a gap in the necessary support services, training, and re-education programs for addressing chronic homelessness. Persons with various degrees of homelessness, tend to re-enter homelessness due to mismanagement and inability to manage monthly income. Inadequate support services are likely to play a role in this trend.

## **CR-30 - Public Housing 91.220(h); 91.320(j)**

### **Actions taken to address the needs of public housing**

The Housing Authority of the City of Killeen (KHA) is now three years into the completion of construction and occupancy of the Rental Assistance Demonstration (RAD) conversion project known as Hyde Estates (Moss Rose phase 1). RAD is the modernization of public housing units into project-based voucher units, which will result in a revenue stream for KHA and further enhance affordable housing within the community. The KHA did not apply with the City to fund programs or projects directly associated with housing or public services for the benefit of remaining public housing residents at the Highview public housing location. The remaining 70 units of public housing at the High View location in Killeen are finally under conversion to RAD, which when complete will end what was once known as public housing. The status of the Moss Rose units is uncertain as the units are not eligible for any type of federal funding due to environmental factors generally associated with HUD and other federal funding sources; it is a possibility that the units may be demolished unless offered for sale to a private investor.

### **Actions taken to encourage public housing residents to become more involved in management and participate in homeownership**

Public housing resident involvement is encouraged and often required. However, it is challenging for lower income persons to engage in management decisions associated with their housing and the transition to homeownership. Although homeownership is desirable, it is generally not feasible due to the costs of normal maintenance of the housing unit, increasing insurance costs for the unit and necessary deductibles required in the event of an insurance claim, the necessity of a desirable/good credit history, and the potential instability of income from employment as it is affected by uncontrolled economic factors. These factors, when coupled together, present a challenge greater than most individuals are willing to engage.

### **Actions taken to provide assistance to troubled PHAs**

At the end of this report period, it is not known whether the Housing Authority of Killeen (KHA) has been or is designated as "troubled" under 24 CFR 902. This last year has been quite tumultuous for the Authority as its financials are not in alignment with HUD requirements, there have been staffing issues and at present the agency has been visited and monitored by HUD resulting in adverse outcomes each time.

## **CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)**

**Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)**

This year as with previous years, there are no overt barriers identified to affordable housing development, with exception to the usual NIMBY-isms associated with the concept of "affordable housing" and the lack of understanding of "low-income" definitions defined by HUD and other U.S. Departments with the purpose of aiding low-income households and families. The City's land use policies continue to encourage the production and preservation of affordable housing. Policies are developed to encourage all types of housing developments with very liberal zoning district standards and subdivision regulations that make the development and maintenance of affordable housing possible. Construction codes allow for renovation of existing, usually older, and more affordable units with keeping occupant safety at the top of the list. Building codes continue to be reviewed to ensure that adopted codes do not discourage different types of development. Building fees for the City are comparable or lower to other similar sized municipalities.

### **Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)**

Assistance was provided to beneficiaries from local service providers who continued previous services, keeping the services available and accessible for needs such as affordable housing, needed support services, and other human service needs (i.e., health care, nutrition, child services including mentoring and family counseling). The Housing Rehab Program assisted two existing homeowners with minor repair/rehabilitation to vital components within the housing structure, and architectural barrier removal for accessibility purposes, as necessary. Public service programs funded under the CDBG program provided parent and child mentoring services to low-income families at the local Killeen Elementary School, case management for veterans and their families, transportation services to sustain the quality of life and independence for elderly persons, acute and chronic health care for uninsured low-income persons, nutrition for aging and elderly persons and case management for homeless persons.

### **Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)**

The CDBG funded Housing Rehabilitation Program continues to provide homeowners with repair to vital components of the housing structure, address issues where lead-based paint is present, and reduce architectural barriers within the home for accessibility purposes.

### **Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)**

Priorities for the past year included continued assistance to local and private agencies and other units of government to be effective in delivering programs to assist in basic daily living among all income levels

in the City and county surrounding Killeen.

**Actions taken to develop institutional structure. 91.220(k); 91.320(j)**

During the 2021 program year, the City of Killeen continued collaborative, and communication efforts with non-profit organizations, public, and private institutions. The City's housing plan was carried out by City staff and subrecipients working under both the CDBG and HOME Programs. The Killeen Housing Authority and Central Texas Council of Governments administer the HUD funded Housing Choice Voucher programs made available to low, and low-moderate income citizens. At the time of this report, both administrators indicate they are closed - taking no new applications for the HCV waiting lists. The City continues to work with various county agencies providing referrals to entities providing housing and social services to eligible City residents. The Department of Veterans Affairs, State Department of Health services, other levels of government, and public service agencies, continued to be instrumental in assisting the city and area non-profits in meeting Plan priorities and delivering successful health and human services to area citizens and the community. These cooperative efforts are also combined with involvement from the private business sector that is responsive to ideas of providing employment opportunities in return for support of their growth initiatives. This framework advances economic development and achieves objectives in meeting under-served community and non-housing needs as detailed in the City's five-year Consolidated Plan

**Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)**

The jurisdiction remains a liaison between the area public and private housing providers by increasing the type and amount of affordable housing within the jurisdiction, including developers attempting to utilize the Housing Tax Credit (HTC) program which requires coordination and support from local service agencies in delivering programs beneficial to low-income households. The area human service agencies continue referring clients for both housing and public services among each other and to additional connections with State and federal programs.

**Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)**

The jurisdiction continued to use the March 2015 Analysis of Impediments (AI) document as a source for addressing impediments to fair housing choice. The March 2015 AI indicated a decrease in the number and size of affordable housing units although there remains ample housing available throughout the jurisdiction.

## **CR-40 - Monitoring 91.220 and 91.230**

The Community Development Department maintains a performance-based system that is used to monitor and evaluate CDBG and HOME funded programs. This system proves to be more effective and assures that subrecipients meet requirements of the federally funded programs, as well as achieve objectives of the 5-year Consolidated Strategic Plan and ensure compliance with long-term requirements of both CDBG and HOME programs. The monitoring program is consistent with performance measurements implemented by HUD. Each activity is categorized into one of three specific objectives, each with specific overarching outcome categories. The jurisdiction continues to encourage the public, local non-profit organizations, county, and state entities to collaborate and coordinate services for the regional area through community planning meetings and agency network meetings. These meetings are intended to receive input on current and future community needs and furthering coordination efforts among area providers. The jurisdiction continues to seek and encourage participation of small, minority, and or women owned businesses in the expenditure of its HUD formula grant programs.

## **Citizen Participation Plan 91.105(d); 91.115(d)**

The jurisdiction, in coordination with the Community Development Advisory Committee (CDAC), provided the community with a fifteen (15) day comment period, commencing on December 5, 2022 and ending on December 19, 2022, on the jurisdiction's 2021 program year (PY2021-22) Consolidated Annual Performance and Evaluation Report (CAPER). The public notice was advertised in the local Killeen Daily Herald newspaper on December 4, 2022. At the close of the comment period, December 19, 2022 - the jurisdiction did not receive any public comment on the 2021 program year, PY2021 2nd Year CAPER.

## **CR-45 - CDBG 91.520(c)**

**Specify the nature of, and reasons for, any changes in the jurisdiction's program objectives and indications of how the jurisdiction would change its programs as a result of its experiences.**

The jurisdiction did make changes to its CDBG programs for the reporting period.

The HOME funded First Time Homebuyer Assistance Program (HAP) was placed on hold due to the rising cost of housing in the local area, inability for buyers to have a nominal (\$1,000) contribution toward purchase, and poor credit scores resulting from the previous pandemic years. Additional changes are likely to come regarding revitalization of housing, single and multi family units, due to lack of interest in the commitment required by the HOME program as investor/developers are in the business to make money and requiring occupancy and rent limits or income restrictions for owner or rental are not enticing. The jurisdiction will refocus on new development of affordable rental housing.

Additional considerations are being made with regard to public facility improvement activities that are not ready to bid once funding allocations are approved in the jurisdiction's Annual Action Plan. This causes the jurisdiction delays on expenditure of its CDBG funding therefore placing the jurisdiction in jeopardy with HUD and the annual timeliness test.

## **CR-50 - HOME 91.520(d)**

The jurisdiction has 3 remaining LIHTC HOME assisted unit sites - Stone Ranch Apartment Homes, Ridge Pointe Apartments, and Tremont Apartments as well as one HOME assisted transitional housing site (6 units) owned by Central Texas Youth Services. Unit inspections were conducted in December 2021 where Tenant rent certifications, rent amounts, and utility allowances were confirmed in the 39 inspections of its HOME assisted rental housing units. As expected, the inspections did not find units out of compliance in documentation or in unit maintenance.

### **Provide an assessment of the jurisdiction's affirmative marketing actions for HOME units. 92.351(b)**

The jurisdiction continues to market all programs when conducting outreach and affirmative marketing for programs managed 'in-house' - Owner Occupied Housing Rehabilitation Program (CDBG).

Existing owner-occupants are generally older and less savvy with 'online' information when it comes to viewing programs that can provide them with updated systems in their home. CD Staff conducts marketing in written form in both the English and Spanish languages. Additionally, the jurisdiction places flyers at local senior and community centers throughout the city ensuring information is available to as many potential owner-occupants as possible. Facebook, Instagram, and Twitter were also major platforms the City used to promote the owner-occupant housing rehabilitation (HRP) program.

Additionally, each subrecipient of both HOME and CDBG funding have specific marketing plans for outreach and affirmative marketing of their individual HOME funded project/activity or CDBG funded housing activities. Specifically, HOME funded units and activities are targeted to individuals and population categories that are unfamiliar with federally funded programs and to those groups of individuals that would not normally apply for assistance. Affirmative Marketing Plans (AMP) provided beneficial information to both participants/beneficiaries and owners/administrators. All affirmative marketing plans include procedures with consistent actions to provide information to and attract and inform eligible persons of available housing opportunities without regard to race, color, national origin, sex, religion, familial status, or disability.

### **Refer to IDIS reports to describe the amount and use of program income for projects, including the number of projects and owner and tenant characteristics**

The jurisdiction did not allocate HOME Program Income (PI) to help supplement HOME admin during FY 21-22. The 10% allowance from the annual entitlement continues to fall short in covering experienced and tenured staff. HOME PI received during the report period totaled \$305,156.00 with \$30,468 being added to HOME Admin costs for FY 22-23 activities. Additionally, the jurisdiction received \$2,148.00 in recaptured funds that must be allocated to the next homebuyer activity once the program is re-established. HOME PI was allocated to the following projects - Killeen Opportunity to End Homelessness: \$ 49,822.00 and to FY 22-23 eligible activity (Affordable Housing \$224,866.00). None of the program income received during FY 21-22 was expended on projects during the report period.

**Describe other actions taken to foster and maintain affordable housing. 91.220(k) (STATES ONLY: Including the coordination of LIHTC with the development of affordable housing). 91.320(j)**

Although the jurisdiction completed all rent and utility assistance during the reporting period, the jurisdiction continued to receive requests for rent and utility assistance from previously assisted households. Many households continued to access other available resources for housing assistance while funding remained. In some cases, the assistance was accessed whether it was needed or not.

Changes to annual income, and the repercussions of slow and no income because of the pandemic wreaked havoc on credit scores for persons of all income levels. The jurisdiction continues to offer no-cost homebuyer education via a recorded course associated with an introduction to buying a home. Registration and completion of the pre-recorded course totaled 251 registrations with only 82 completing the course and 'knowledge check' (quiz) on the material presented. Most low-income households are still recovering from the effects of the pandemic and still do not have funds more than their everyday needs to be used for the purchase of a home.

A recent report "Killeen has Been Discovered!" by the Texas State Demographer, shows that the City of Killeen's housing affordability and proximity to the I-35 corridor has brought in many new investors coming to the area who purchase older rental units and increasing the monthly rent on long time tenants. Because tenants can't afford the new rents they are forced out or to they pay more than they can afford to remain in the unit. The jurisdiction received calls requesting legal assistance against landlords/owners for multiple rent increases during a six-month period. Fair Market Rent (FMR) levels increased just slightly (less than 1%) over the previous year with the two-bedroom unit FMR remaining the same as the 2021 FMR for the Killeen-Temple, TX Metropolitan Statistical Area (MSA) as \$815 monthly.

CD Staff worked with the tenant and some owner/landlords to help each understand the commitments made by both parties as detailed in the varying lease documents. Staff continued assisting the tenants to find available rental units that were in the price range they could afford. This activity also prevented the jurisdiction from implementing an affordable housing redevelopment activity in the local target area

on the Northwest side of Killeen; North Killeen Housing Redevelopment (NKHRD) program. NKHRD is a program geared to stabilizing and, as necessary, redeveloping housing units in the North Killeen local target area. The NKHRD is a multi-faceted housing rehabilitation program focusing on single family homes, multi-family units with rehabilitation to reconstruction to maintain housing quality and affordability for low-income households. These funds may need to be reprogrammed for other eligible HOME uses if interest cannot be garnered in the coming quarter of the new report period.

**Narrative**

The jurisdiction continues to promote efforts associated with the hiring of low-income and target workers when advertising and bidding its HUD formula grant programs.

For projects involving construction the jurisdiction totaled five (5) projects with a total of 186 labor hours. These projects included instruction in the bidding process of the jurisdiction’s “Economic Opportunities Through Community Development Projects - Section 3 Eligibility Guidelines” outlining the requirements in its HUD funded programs, instruction during the pre-bid conference on the ease of documentation and submittal of the documentation once during the project life, unless new laborers or mechanics were added after the project began. Bidders are required to complete necessary forms associated with their proposed efforts that will be made to hire low-income and target Section-3 workers. Once the project is awarded, information is then conveyed in the pre-construction meeting regarding hiring for the project. CD Staff reviews the certified payroll documentation calculating the qualifying labor hours and workers for each project.

The 2019 CDBG funded project – Clements Boys and Girls Club North Killeen Gymnasium and Teen Center project resulted in 186 labor hours completed by low-income Section – 3 workers.
