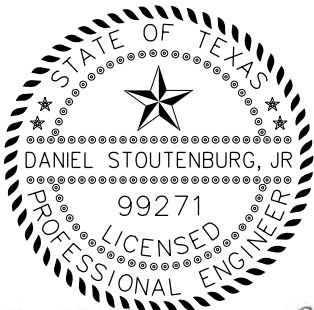

- 1.01 Amend the Contract Documents

### 2.02 Section “Instruction to Bidders”

#### A. Item 5”, Delete “420 consecutive calendar days” and replace with “540 consecutive calendar days”

### 2.03 Section 00 41 13 “Standard Form of Agreement between Owner and Contractor on the Basis of a Stipulated Price”

#### A. Delete Paragraph 4.02 A and replace with the following:

The Work will be substantially completed within **540** days after the date when the Contract Times commence to run as provided in paragraph 2.03 of the General Conditions, and completed and ready for final payment in accordance with paragraph 14.07 of the General Conditions within **600** days after the date when the Contract Times commence to run.
